In consideration of being allowed to participate in the Activities (as defined below) purchased from All Roads Travel LLC, a Delaware limited liability company with offices in Las Vegas, Clark County, Nevada, together with its brands and affiliates, including Formals, Customizable Group Travel, and JusCollege ("**All Roads Travel LLC**"), I hereby understand and agree to this ACKNOWLEDGMENT OF RISK, ASSUMPTION OF RISK AND RESPONSIBILITY, RELEASE OF LIABILITY AND WAIVER OF LEGAL RIGHTS on the terms set forth below.

Acknowledgment of Risk

I acknowledge that I have voluntarily agreed to purchase an Activity or Activities (as defined below).

Activities covered by this document include: air, water, rail and ground transportation; hotel and other accommodations; restaurant reservations and other food and beverage packages; tours; sightseeing excursions; live entertainment events and festivals; and other services and activities, including any recreational and water activities, sold by All Roads Travel LLC (separately, each an "**Activity**" and collectively, the "**Activities**"). ALL Activities are operated and provided by various third-party suppliers and NOT by All Roads Travel LLC.

I acknowledge that there are significant elements of risk while traveling, either domestically within the United States or to foreign countries, and while participating in activities associated with travel, events, the outdoors, water activities, and activities incidental thereto.

I understand that I may travel to remote countries and areas that are inherently risky. I am prepared to assume all risks associated with the Activities, including but not limited to: forces of nature; terrorism; civil unrest; war; accidents; and transportation, including land vehicles, boats, and aircraft, that may not be operated or maintained to standards found in the United States of America. I also assume risks associated with altitude, illness, disease, physical exertion, known or unknown medical conditions, tainted food, and the consumption of alcohol; encounters with

insects or animals; exposure to the elements, including heat, sun, water, and wind; conditions in and around the water, including tides, rip tides, currents, marine life, and my own ability to swim; the negligence or lack of training of any agents or employees of All Roads Travel LLC; my own negligence or the negligence of others; and the knowledge that access to evacuation and/or suitable medical supplies and support may not be available.

I further acknowledge and assume the risk that injury, loss, harm, or damage may result from my own voluntary acts, decisions, choices, judgment, and conduct, and from the acts, decisions, choices, judgment, and conduct of other travelers or third parties, that are beyond the control of All Roads Travel LLC. I understand and agree that All Roads Travel LLC is not responsible for, and exercises no control over, the personal decisions I make or the manner in which I choose to conduct myself during the Activities.

I acknowledge that infectious and communicable diseases, including COVID-19, are an inherent risk of travel that cannot be controlled or eliminated by All Roads Travel LLC, and that exposure to or infection by such diseases may result in personal injury, illness, permanent disability, or death. I voluntarily assume this risk. I further understand that certain destinations may impose entry, testing, vaccination, or quarantine requirements that can change without notice, that I am solely responsible for understanding and meeting these requirements, and that they may delay, interrupt, or prevent my travel without refund.

I understand that the description of these risks is not complete and that unknown or unanticipated risks may result in injury, illness, or death. I agree to take full responsibility for my own actions, safety, and welfare. I also understand that I may be a member of a group, and if I am a member of a group, I will conduct myself in a way that will not endanger the group or myself. I understand that if I fraudulently represent myself as fit for this trip, I may be removed prior to or during the trip at my own expense.

Assumption of Risk

The Activities, by their very nature, carry with them certain inherent risks that cannot be eliminated regardless of the care and steps the Releasees (as defined below) or the third-party supplier operating and providing the Activity(ies) have taken to avoid injuries. I acknowledge that the same elements that contribute to the unique character of these Activities can cause loss or damage to my equipment, accidental injury, illness, or, in extreme cases, permanent trauma, disability, or death.

I EXPRESSLY AND VOLUNTARILY ASSUME ALL RISK OF DEATH, ECONOMIC LOSS, DAMAGE TO PERSONAL PROPERTY, OR PERSONAL INJURY SUSTAINED WHILE PARTICIPATING IN ACTIVITIES, WHETHER OR NOT CAUSED BY THE NEGLIGENCE OF THE RELEASEES (as defined below). I hereby assert that my participation in an Activity(ies) is voluntary and that I knowingly assume all such risks, including those risks not specifically identified. I further understand that I am ultimately responsible for my own safety.

Release

I (and on behalf of my spouse, my heirs, executors, administrators, legal representatives, assignees, and successors in interest (collectively, "**Successors**")) take full responsibility for, and agree to forever release, hold harmless, and discharge All Roads Travel LLC, its brands and affiliates (including Formals, Customizable Group Travel, and JusCollege), its owners, officers, affiliated companies, suppliers, promoters and partners, venue and hotel operators, agents, and employees (collectively, the "**Releasees**") from any and all liability, claims, demands, or causes of action that I may hereafter have for injuries, loss or damage to person or property, death, delay, inconvenience, or damages arising out of my participation in an Activity(ies), including, but not limited to, losses CAUSED BY THE NEGLIGENCE OF THE RELEASEES. Furthermore, and without limitation, the Releasees are not responsible for, and will pay no compensation or refund for, any injury, loss, or damage to person or property, death, delay, or inconvenience in connection with the provision of any goods or services occasioned by or resulting from, but not limited to: acts of God or force majeure; acts of war or civil unrest; insurrection or revolt; strikes or other labor activities; epidemics or pandemics; quarantine; acts of government; criminal or terrorist activities of any kind; overbooking or downgrading of accommodations; mechanical or other failure of airplanes or other means of transportation; or any failure of any transportation mechanism to arrive or depart timely.

I acknowledge and realize that by agreeing to this ACKNOWLEDGMENT OF RISK, ASSUMPTION OF RISK AND RESPONSIBILITY, RELEASE OF LIABILITY AND WAIVER OF LEGAL RIGHTS, I am waiving and contractually agreeing to waive all of my rights to sue, make a claim, and/or bring any type of action for any loss against any of the entities, individuals, and Releasees set forth above and described herein.

I fully understand that this agreement not to bring any type of action includes claims I might have for the ordinary negligence and/or carelessness of the Releasees. This release is for any type of claim, including any property damage and loss, personal injury, emotional distress, illness, disability, and death related to my participation in an Activity(ies), my use of any equipment or facilities, or my travel to or return from the Activity.

Indemnification

I agree to hold harmless, defend, and indemnify the Releasees from all defense costs (including attorney's fees, court costs, and investigative costs) incurred in connection with all claims arising out of property damage, property loss or theft, personal injury, disability, death, or other loss brought by or on behalf of me, a family member, or my estate, as well as claims of co-participants, rescuers, spectators, or any other person or entity, including third-party claims, arising from or relating to my use of the equipment, facilities, and/or participation in the Activity, including claims that the Releasees were negligent.

Health and Safety

I agree it is my sole responsibility to be familiar with the Releasees' rules, guidelines, special regulations, and other instructions for the Activity. I understand and agree that situations may arise during the Activity that may be beyond the immediate control of the Releasees. I will follow all safety rules, guidelines, applicable laws, and other instructions given. I will wear required safety equipment, including a personal flotation device at all times while participating in water activities or while in any watercraft. I have no physical or medical condition that, to my knowledge, would endanger others or myself if I participate in this Activity or that would interfere with my ability to participate in this Activity. I grant the Releasees permission (but by no means are the Releasees required) to treat me in case of illness, injury, emergency, or accident, including administering first aid, CPR, or AED, or arranging emergency transport. Should emergency medical services become necessary, I understand that the expenses are my responsibility and not those of the Releasees. I understand that personal medical and travel insurance are required of all participants by All Roads Travel LLC.

Photo Waiver

I hereby grant full permission for All Roads Travel LLC, and its respective agents, boards, commissions, and any other involved parties of the foregoing, to take and use photographs, video, film, or any other record of this Activity, including my name, likeness, and/or voice, for any legitimate purpose, including advertising, display, audiovisual presentations, or otherwise. I waive any right of privacy, publicity, compensation, copyright, or other rights to those images.

Severability

Every term and provision of this ACKNOWLEDGMENT OF RISK, ASSUMPTION OF RISK AND RESPONSIBILITY, RELEASE OF LIABILITY AND WAIVER OF LEGAL RIGHTS is intended to be severable. If any one or more of them is found to be unenforceable or invalid, that shall not affect the other terms and provisions, which shall remain binding and enforceable. This document is entered into voluntarily, after careful consideration, and is binding upon the person signing below and their Successors.

Legally Binding Contract

I hereby expressly recognize that this ACKNOWLEDGMENT OF RISK, ASSUMPTION OF RISK AND RESPONSIBILITY, RELEASE OF LIABILITY AND WAIVER OF LEGAL RIGHTS is a contract pursuant to which I have released any and all claims against the Releasees resulting from any injury or death sustained from participation in an Activity(ies), including any claims for the negligence of the Releasees.

I further represent that I am at least 18 years of age, and I waive and release any and all legal rights that may accrue to me as a result of any injury or death I may suffer while engaging in the Activity.

Governing Law

This ACKNOWLEDGMENT OF RISK, ASSUMPTION OF RISK AND RESPONSIBILITY, RELEASE OF LIABILITY AND WAIVER OF LEGAL RIGHTS is incorporated into and forms part of the All Roads Travel LLC Booking Conditions. It is governed by the laws of the State of Nevada without regard to conflict of law provisions. You and All Roads Travel LLC submit to the personal and exclusive jurisdiction of the state and federal courts located within Clark County, Nevada for resolution of any lawsuit or court proceeding permitted under the Booking Conditions and this document. All traveler claims must be submitted in writing and received by All Roads Travel LLC no later than sixty (60) days after the completion of the trip. Traveler claims not submitted and received within this time shall be deemed waived and barred.

I HAVE READ THIS ACKNOWLEDGMENT OF RISK, ASSUMPTION OF RISK AND RESPONSIBILITY, RELEASE OF LIABILITY AND WAIVER OF LEGAL RIGHTS AND FULLY UNDERSTAND ITS CONTENTS. I ENTER IT OF MY OWN FREE WILL.
